

# Promotion terms and conditions

Dry and safe into spring with the Lovens Rain Canopy and LED' 2026 campaign conditions

## I. General

These terms and conditions (the ‘Promotion Terms and Conditions’) apply to the Lovens promotion ‘free Rain Cover and LED daytime running lights when purchasing a Lovens Explorer 1 (hereinafter referred to as: the “Promotion”) of Optima Cycles Trading B.V. (hereinafter referred to as: the “organiser”), with its registered office and place of business at Beveland 2 Beverwijk.

The promotion applies to the Lovens Explorer 1 model types: S85 AUTO ABS, S85 ABS, S85 AUTO, S85, S75 AUTO ABS, S75 ABS, S75 AUTO, S75 and S50.

The promotion does not apply to the model types Lovens Explorer 1 50, 65, 65 AUTO, 85 and 85 AUTO.

The value of the Rain Cover is €359.95. The value of the LED daytime running lights is €129.95.

The purchase of a Lovens including free Rain Cover + LED runs from 1 February 2026 to 28 February 2026 (the ‘promotional period’). The invoice date must fall within this date. Registration to receive the Rain Cover and LED daytime running lights is through the Lovens point of sale. Registration is possible until 31 March 2026.

The organiser reserves the right at any time, without giving reasons, to discontinue the promotion or to amend the promotion terms and conditions in the interim. If the promotion terms and conditions are revised, the latest version, provided with a date, will be posted on the organiser's website.

The organiser and participants are bound by the content and provisions of these action terms and conditions. By participating in the promotion, the participant agrees to these promotion terms and conditions.

## II. Conditions of action

There are two options for sending the Rain Cover: the option of sending the Rain Cover to the consumer via parcel delivery to the address entered. Or the Rain Cover is delivered to the point of sale itself. The point-of-sale indicates this option when submitting the claim via the webshop.

The LED daytime running lights are provided by the point of sale.

Participation in the promotion is possible by purchasing a new Lovens Explorer 1 BES 3 model at an official Lovens point of sale during the promotion period. The staff at your point of sale must submit the promotion via the webshop by registering the invoice and the bike's frame number. The point of sale is responsible for registering the bike on time and providing the correct details to qualify for the promotion.

Participation in this promotion is (exclusively) for individuals who have purchased a Lovens Explorer 1 (of the type mentioned in the first paragraph) at a Lovens point of sale during the promotion period and have registered the invoice with the frame number on the promotion page.

Participation in this promotion is (exclusively) for the purchase of a new Lovens Explorer 1 model at an official Lovens point of sale. Second-hand sales are excluded. Participation in this promotion is (exclusively) for individuals who have reached the age of 18.

Employees of Optima Cycles B.V. are excluded from participation.

Only one participation is allowed per person.

If the Rain Cover is not immediately available, delivery will be postponed to the next available date, with a maximum of 6 weeks after registration. The promotion is valid while stocks last. This promotion is not valid in combination with other promotions.

In case of cancellation of the Lovens Explorer 1 purchase, the promotion will be void.

The organizer reserves the right to refuse participations that do not meet these conditions or that appear fraudulent. The organizer reserves the right to exclude a participant with invalid or falsified personal data from participation.

In case of fraud, or suspicion thereof, or unlawful influence on the promotion, the organizer reserves the right to exclude participants from participation.

The discount is not redeemable for cash.

### **III. Code of Conduct**

Participants may not use the promotion to express political or religious views.

Participants may not taunt, curse, discriminate, or make sexual innuendos.

Entries must not be offensive, insulting, obscene, tormenting, hateful, shocking, immoral, violent, sexually suggestive, racist, defamatory, libelous, discriminatory, or contrary to good taste or decency, or incite such behaviour.

Optima Cycles will retain personal data only for as long as necessary for the purposes described above.

Participants have a right of access and a right to rectify their personal data, as well as a right to object to the use of such data.

The organizer and/or the persons it engages are not responsible or liable for disruptions in and/or errors with respect to the internet, the promotion page, any of the websites mentioned in these terms and conditions, the cable (or any other relevant) network, software or hardware, as well as for any incorrect input and/or processing of personal data.

The organizer is also not liable for any costs, damage, additional expenses incurred by participants if it turns out that the accessories are not available on their desired or booked day and/or time.

Errors in printing, spelling, typesetting, or any similar material errors are of no value and cannot be invoked as legal remedies against the organizer. Furthermore, the organizer excludes any liability of

the organizer and/or the points of sale it engages in connection with this promotion, including the prize, except in the case of intentional or gross negligence by the executive staff of the organizer.
